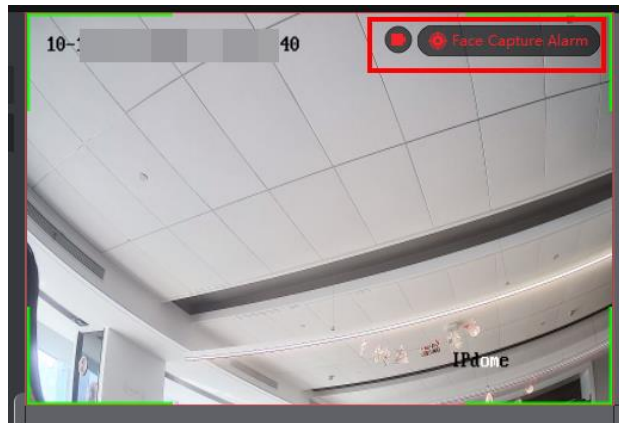
2.1 Live View
